SAMPLE QUESTIONS

The examination for a taxi cab driver license may include questions on geography, map reading, address location, planning routes, TLC Rules and Regulations and other related areas. Some questions on the examination are "open-book," meaning that you are allowed to use a map and an address locator when answering these questions. Some of the questions on the examination are "closed-book," meaning that you are allowed no external aids when answering these questions. Questions dealing with TLC Rules and Regulations are generally closed-book, as are some questions dealing with the geography of the NYC area.

The sample questions given below are intended as **samples** only. Although the subject matter of the questions given here might **not** be on the actual test, they will show you a sample of the style of some questions you can expect on the test. Though only 25 questions are presented here, there will be more than 25 questions on the actual test.
